## CAMP HOUSEKEEPING AND SAFETY GUIDELINES

### Before Camp:

Each camper must have a signed release of Liability Wavier on file with the office.

### Drop Off:

- ★ Be sure you have designated on the emergency information form who will be dropping off and picking up your child from camp each day.
- ★ Do not drop off your child any earlier than 10 minutes before camp.
- ★ Upon arrival on the first day, stop at the registration table to be sure we have all the emergency, liability waiver, and emergency forms on file.
- ★ You must walk your child to and from camp each day of camp. Do not Drop your child off.

### Pick Up:

- ★ Please arrive promptly at the MCP Studio theater to pick up your child each day of camp. If a parent is consistently late, we reserve the right to prohibit your child from continuing with the theatre camp.
- ★ Do not wait in the parking lot and ask your child to walk unescorted.
- ★ Appropriate behavior is expected. Campers will be prohibited from continuing with camp for misbehavior.
- ★ MCP camp staff cannot dispense medication.

## REGISTRATION DEADLINE

The registration deadline for the Monroe Community Player Theatre Camp is one week prior to the start date, June 19th. We must order camp T-Shirts and supplies for each camper. Last minute registration may not be accepted and a T-Shirt may not be available.
